RESOLUTION TO PURCHASE 72-PASSENGER TRANSIT SCHOOL BUSES AS BID BY THE OHIO SCHOOLS COUNCIL

WHEREAS, the Canton City School District is a member of the Ohio Schools Council; and

WHEREAS, the Ohio Schools Council advertised for bids for school buses; and

WHEREAS, the bids were received on Tuesday, October 1, 2019 and reviewed by the bus bid review committee for compliance; and

WHEREAS, Cardinal Bus Sales & Service, Inc. submitted a bid for a 72-passenger transit school bus with specifications, acceptable to the Canton City School District.

Cardinal Bus Sales & Service, Inc.

72-Passenger Transit Bus (each-as specified) \$88,386.00

THEREFORE, BE IT RESOLVED, that the Canton City School District Board of Education hereby is awarded the contract as detailed above for 12 (twelve) 72-passenger transit school buses, totaling \$1,060,632.00; and

BE IT FURTHER RESOLVED that the Canton City School District Board of Education does hereby reject all other bids submitted on this project.
