WHEREAS, the Board presently employs Romero Harris pursuant to a supplemental contract as Baseball Coach with related weight room duties;

WHEREAS, the Board compensates Frank McLeod, Zachary Sweat, and Josh Grimsley for services performed in the capacity of Assistant Football Coaches; and

WHEREAS, the Board finds that Marcus Watley, Cade Brodie, Tyler Thatcher, Romero Harris, Frank McLeod, Zachary Sweat, and Josh Grimsley did orchestrate, engage in, permit, and/or acquiesce to conduct unbecoming their profession on May 24, 2021.

NOW, THEREFORE, BE IT RESOLVED by the Board:

1. Upon the recommendation of the Superintendent, and although the aforementioned supplemental contracts would expire by operation of law, the Board hereby affirmatively

non-renews the supplemental contracts of Marcus Watley, Cade Brodie, Tyler Thatcher, and Romero Harris.

2. Upon the recommendation of the Superintendent, and although there exists no expectation of continued compensation, the Board hereby affirmatively declares that the following individuals are ineligible for future compensation by the Board in a coaching capacity: Frank McLeod, Zachary Sweat, and Josh Grimsley.

3. The Board hereby authorizes the Board President, Superintendent, and Treasurer to take all action as may be necessary to implement this Resolution.

4. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public or in executive session as permitted by Ohio law.

5. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
